

Important information: Changes to collection devices

With the availability of liquid Amies swabs, one swab type can now be used for both PCR and MCS. As these new swabs are suitable for both test systems, we expect that they will reduce the likelihood that a recollection is needed because of collection with an incorrect swab type.

As we transition to a simpler swab system, you may still have stock of the previously available swabs. We will continue to accept samples collected with these swabs.

General tips

- Check expiry date of swabs before collection.
- One anatomical site per collection device (except for respiratory viruses, when both an NPS and a throat swab are required).
- Label swabs with patient's full name, date of birth, collection site(s), and time and date of collection.
- Ensure the lid is firmly placed/screwed on all collection devices containing specimens.
- Do not refrigerate swab specimens.

Reminder to return Surgical Skin Cancer and CST audit evaluation forms

CST audits that final interval evaluation forms must be returned by October so they can be processed and the relevant colleges notified. We urge you to return them as soon as possible so that your CPD points can be awarded.

The final interval report for the Surgical Skin Cancer Audit that will contribute to an audit in this triennium will be ready by the end of September. A report will also be issued for the October to December interval, which will enable you to continue to review your outcomes.

All doctors who have participated in the audits in this triennium will be automatically registered for the new triennium.

HPV self-collected test: Update

- We are undergoing accreditation for self-collected HPV testing.
- This will reduce turnaround times.
- We ask our referring doctors to provide us with two self-collected samples per patient so that one of them can be used in our validation process.

Sullivan Nicolaides Pathology is validating its testing process for accreditation for self-collected HPV samples. At present, self-collected HPV samples are being sent to our partner laboratory, Douglass Hanly Moir, in Sydney. Conducting these tests in Brisbane will reduce turnaround times.

The introduction of a self-collected HPV test is an important new component of the National Cervical Screening Program. While only offered to a limited number of women meeting strict funding criteria, the self-collected HPV test is intended to increase program participation by offering an acceptable alternative to those women who previously, for various reasons, have not felt comfortable to take part in this important women's health program.

We would like our doctors to please ask patients to collect two HPV samples so that one can be used to validate our testing process.

How to collect:

The patient must collect the sample in the surgery or healthcare clinic using a red-topped Copan dry FLOQSwab. The swab should be immediately returned to the clinician for referral to the testing laboratory.
