# Coronavirus (2019-nCoV) Requests

SNP has a number of specialised collection centres where collectors have been trained to safely and efficiently collect combined nasopharyngeal and oropharyngeal swabs for the diagnosis of respiratory viruses, including 2019-nCoV.

As the 2019-nCoV outbreak progresses and the capacity to test has increased, the restrictions on who should be tested have changed over time. Testing is still recommended for those patients who fulfil the epidemiologic and clinical definition for investigation for 2019-nCoV infection. This includes travel to mainland China in the last 14 days and becoming symptomatic (fever and/or cough and/or shortness of breath and/or sore throat) OR persons who are symptomatic and have had close or casual contact in 14 days before illness onset with a confirmed case of 2019-nCoV.

Whilst mainland China remains the high-risk area of travel, other destinations will be considered. Clinical judgement should be used to determine the need for testing in patients who do not meet the epidemiological or clinical criteria above. Testing of asymptomatic individuals is not recommended.

Public health approval is no longer required to request testing. However in very high risk patients the relevant public health unit still requests early clinical notification of a suspect case, even prior to test results being available. As at 30 January 2020,

2019-nCoV is a notifiable condition in Queensland.

The preferred specimens include combined nasopharyngeal and oropharyngeal flocked swab.

If a sputum sample is available this should also be submitted. All samples will undergo normal respiratory virus testing in addition to 2019-nCoV. In high risk patients a serum sample may also be collected for future 2019-nCoV antibody testing.

The examinations, which are held each December in Frankfurt, Germany, are organised jointly by the International Committee

for Dermatopathology (ICDP) and the European Union of Medical Specialists (UEMS). A key aim of the certification, introduced in 2003, is to drive harmonisation through internationally recognised standards.

The curriculum incorporates the rapid advancements in molecular medicine that are transforming diagnostic and prognostic testing.
